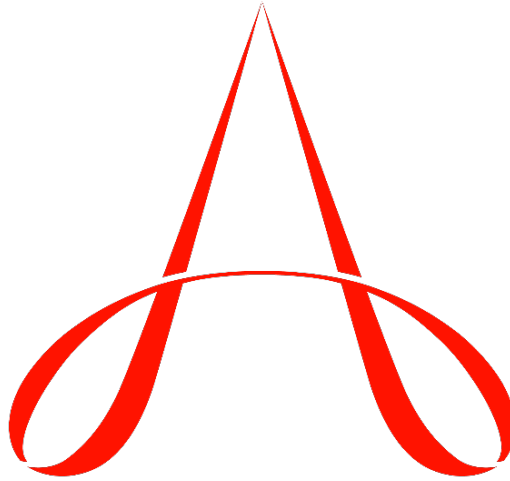

Milestones Supplemental Guide

This document provides additional guidance and examples for the Transplant Hepatology Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

<p>Level 1 <i>Accesses data and gathers a history standard for general internal medicine</i></p> <p><i>Performs a physical examination standard for general internal medicine</i></p> <p><i>Selects and interprets diagnostic tests, with significant assistance</i></p>	<ul style="list-style-type: none"> ● Obtains a general history and performs a general physical exam on a patient presenting with symptoms of anemia and orders a complete blood count (CBC) and iron panel
<p>Level 2 <i>Gathers a symptom-specific history and data, with assistance</i></p> <p><i>Performs a symptom-specific physical examination, with assistance</i></p> <p><i>Selects and interprets diagnostic tests, with moderate assistance</i></p>	<ul style="list-style-type: none"> ● After discussing the patient with the attending, obtains a gastroenterology (GI)-specific history, performs a rectal exam and recommends an upper endoscopy and colonoscopy
<p>Level 3 <i>Gathers data from multiple sources and collects symptom-specific history, including psychosocial issues</i></p> <p><i>Performs a symptom-specific physical examination, without assistance</i></p> <p><i>Selects and interprets diagnostic tests, with minimal assistance and general awareness of cost effectiveness and patient preferences</i></p>	<ul style="list-style-type: none"> ● Inquires about family history of peptic ulcer disease and colon cancer, personal history of alcohol use, and obtains prior CBC values ● Examines a patient with abnormal liver tests for cutaneous stigmata of chronic liver disease without direction from the attending ● Orders an iron panel on a patient with cirrhosis before ordering hemochromatosis genetic testing
<p>Level 4 <i>Consistently synthesizes data from multiple sources</i></p> <p><i>Consistently performs a symptom-specific physical examination</i></p>	<ul style="list-style-type: none"> ● Consistently requests prior records on patients presenting with abdominal pain ● Evaluates for pelvic floor dysfunction during the rectal exam on patients presenting with constipation

<p><i>Independently selects and interprets diagnostic tests with adjustment based on cost effectiveness and patient preferences</i></p>	<ul style="list-style-type: none"> ● Recommends noninvasive tests for colorectal cancer screening in a patient who refuses colonoscopy
<p>Level 5 <i>Role models gathering and synthesis of clinical information</i></p>	<ul style="list-style-type: none"> ● After reaching out to other providers and reviewing medical records, creates a summary and corrects misinformation in the chart
<p><i>Interprets subtleties of diagnostic test results to improve patient care</i></p>	<ul style="list-style-type: none"> ● Evaluates for celiac disease in a patient with elevated liver enzymes

Patient Care 2: Patient Management in Gastrointestinal and Liver Disease Overall Intent: To develop a comprehensive care plan for gastrointestinal and liver disease based on disease presentation and urgency	
Milestones	Examples
<p>Level 1 <i>Develops focused care plans, with moderate assistance</i></p> <p><i>Requires direct supervision to prioritize and deliver patient care</i></p> <p><i>Recognizes situations requiring urgent or emergent care, with significant assistance</i></p>	<ul style="list-style-type: none"> ● Orders a hepatitis panel for a patient presenting with abnormal transaminases ● After examining a patient presenting to the emergency department with a GI bleed, speaks with attending about next steps ● Recognizes acute liver failure after attending asks to check international normalized ratio ● Immediately calls the attending after the consult is received to determine when to re-evaluate patient
<p>Level 2 <i>Develops focused care plans, with minimal assistance</i></p> <p><i>Manages patients with straightforward diagnoses, with minimal assistance</i></p> <p><i>Recognizes situations requiring urgent or emergent care, with minimal assistance</i></p>	<ul style="list-style-type: none"> ● Orders hepatitis panel, autoimmune serologies, iron studies, and genetic testing for a patient presenting with abnormal transaminases based on clinical presentation ● Titrates diuretics for patients with ascites with minimal assistance ● Recognizes acute liver failure after reviewing labs and clinical presentation
<p>Level 3 <i>Independently develops focused care plans</i></p> <p><i>Independently manages patients with straightforward diagnoses</i></p> <p><i>Manages urgent and emergent situations, with minimal assistance</i></p>	<ul style="list-style-type: none"> ● Independently synthesizes treatment plan for patient with cirrhosis ● Independently manages a patient with primary biliary cholangitis ● Recognizes acute liver failure and appropriately initiates liver transplant evaluation
<p>Level 4 <i>Modifies care plans based on patient's clinical course, additional data, patient preferences, and cost-effectiveness principles</i></p> <p><i>Independently manages patients with complex and undifferentiated syndromes, and recognizes disease presentations that deviate from common patterns</i></p>	<ul style="list-style-type: none"> ● Modifies management plan for a patient with newly decompensated cirrhosis ● Independently develops and implements a plan for steroid taper for a patient with autoimmune hepatitis and monitors response, adjusting steroid dose between visits ● Independently manages patients with autoimmune hepatitis with lack of response to steroid therapy suggesting overlap syndrome

<p>Level 5 <i>Develops customized, prioritized care plans for complex patients, incorporating diagnostic uncertainty and cost-effectiveness principles</i></p> <p><i>Effectively manages unusual, rare, or complex disorders</i></p>	<ul style="list-style-type: none"> ● Diagnoses and treats patient with gastrointestinal bleeding due to innumerable angioectasias of the small bowel ● When managing a patient who declines blood products, identifies bloodless therapeutic strategies

Patient Care 3: Technical Procedures – Liver Biopsy	
Overall Intent: To independently perform a liver biopsy including all aspects of the pre- and post-procedural assessment, including evaluation of complications	
Milestones	Examples
<p>Level 1 <i>Performs peri-procedural assessment, including required diagnostic testing and selection of equipment, with moderate assistance</i></p> <p><i>Only performs portions of the procedure, and recognizes complications, with significant assistance</i></p>	<ul style="list-style-type: none"> ● Learner requires prompting for need of liver biopsy in a patient with elevated liver enzymes post-transplant ● Demonstrates knowledge of peri-procedural assessment including indications, contraindications, limitations, complications, alternatives, and techniques of liver biopsy ● Identifies site of biopsy, prepares the skin, positions the patient, and administers local anesthesia
<p>Level 2 <i>Performs peri-procedural assessment, including required diagnostic testing and selection of equipment, with minimal assistance</i></p> <p><i>Performs significant portions of the procedure and recognizes complications, with moderate assistance</i></p>	<ul style="list-style-type: none"> ● Determines need for a liver biopsy, evaluates patient, determines if sedation is needed, and obtains informed consent ● Performs liver biopsy and obtains adequately sized sample with moderate verbal coaching throughout the procedure
<p>Level 3 <i>Independently performs peri-procedural assessment, including required diagnostic testing and selection of equipment in standard cases</i></p> <p><i>Performs the complete procedure and recognizes complications, with minimal assistance</i></p>	<ul style="list-style-type: none"> ● Determines need for a liver biopsy, evaluates patient, determines if sedation is needed, obtains informed consent, and checks labs/imaging studies to ensure safety for the patient ● Performs liver biopsy and obtains adequately sized sample with minimal verbal coaching
<p>Level 4 <i>Independently performs peri-procedural assessment, including required diagnostic testing in complex cases</i></p> <p><i>Independently performs the complete procedure with patient comfort and adequate specimen collection and recognizes complications</i></p>	<ul style="list-style-type: none"> ● Determines best route to perform liver biopsy in a patient with coagulopathy ● When an adequate sample is not obtained after several attempts, appropriately aborts the procedure ● Manages a patient with post procedural abdominal pain and recommends imaging to rule out a complication
<p>Level 5 <i>Teaches others to perform liver biopsy</i></p>	<ul style="list-style-type: none"> ● Leads another fellow through every single step of liver biopsy

<p>Level 1 <i>Demonstrates basic knowledge of specialty disorders</i></p> <p><i>Demonstrates basic knowledge of diagnostic, therapeutic/ pharmacologic categories for prevention and treatment of disease</i></p>	<ul style="list-style-type: none"> ● Lists causes of post-transplant rejection ● Lists categories of anti-rejection drugs
<p>Level 2 <i>Demonstrates expanding knowledge of specialty disorders</i></p> <p><i>Demonstrates expanding knowledge of diagnostic, therapeutic/ pharmacologic options for prevention and treatment of diseases, including indications, contraindications, limitations, complications, alternatives, and techniques</i></p>	<ul style="list-style-type: none"> ● Recognizes the role of palliative medicine in an end-stage liver disease patient ● Identifies appropriate antirejection medications based on medical comorbidities
<p>Level 3 <i>Demonstrates broad knowledge of specialty disorders</i></p> <p><i>Demonstrates broad knowledge of diagnostic, therapeutic/ pharmacologic options for prevention and treatment of diseases</i></p>	<ul style="list-style-type: none"> ● Creates a differential for diagnosis for acute liver failure in pregnancy ● Interprets the results from therapeutic drug monitoring for a patient with a liver transplant
<p>Level 4 <i>Synthesizes advanced knowledge of specialty disorders to develop personalized interventions</i></p> <p><i>Synthesizes advanced knowledge to select diagnostic, therapeutic/ pharmacologic options for prevention and treatment of disease</i></p>	<ul style="list-style-type: none"> ● Discusses the risk/benefit for repeat orthotopic liver transplantation in a patient with a prior transplantation who develops new cirrhosis and congestive heart failure ● Understands the risks/benefits for anti-viral therapy in a pregnant patient with hepatitis B
<p>Level 5 <i>Demonstrates expert knowledge within a focused area</i></p>	<ul style="list-style-type: none"> ● Demonstrates knowledge of evolving therapeutic targets for drug development in non-alcoholic steatohepatitis
<p>Assessment Models or Tools</p>	<ul style="list-style-type: none"> ● Chart stimulated recall ● Direct observation ● Gastroenterology Training Exam

Medical Knowledge 2: Clinical Reasoning	
Overall Intent: To provide specialty-specific care for patients with gastrointestinal and hepatic diseases/disorders	
Milestones	Examples
Level 1 <i>Creates a focused differential diagnosis with moderate assistance</i>	<ul style="list-style-type: none"> ● Needs assistance listing causes of acute abdominal pain
Level 2 <i>Creates a focused differential diagnosis with minimal assistance</i>	<ul style="list-style-type: none"> ● Lists most common causes of acute abdominal pain
<i>Differential diagnosis remains fixed despite new information</i>	<ul style="list-style-type: none"> ● Does not expand the differential when a computerized tomography (CT) scan demonstrates inflammatory changes around the terminal ileum
Level 3 <i>Independently creates a succinct, plausible, and prioritized differential diagnosis appropriate for the presentation of a patient with an uncomplicated presentation</i>	<ul style="list-style-type: none"> ● Prioritizes acute appendicitis in a patient with migrating abdominal discomfort localizing to the right lower quadrant, rebound, and fever
<i>Consistently incorporates new information to adjust differential diagnosis</i>	<ul style="list-style-type: none"> ● Adds inflammatory bowel disease or Yersinia to the differential when a CT scan demonstrates inflammatory changes around the terminal ileum
Level 4 <i>Independently creates a succinct, plausible, and prioritized differential diagnosis appropriate for the presentation of a patient with complex and/or multiple problems</i>	<ul style="list-style-type: none"> ● Synthesizes history and physical and diagnostic testing in neuroendocrine tumor of the terminal ileum
<i>Consistently evaluates and adjusts differential diagnosis integrating available new information and recognizing the factors that lead to bias</i>	<ul style="list-style-type: none"> ● Does not anchor on Crohn's disease when learning about a family history of Crohn's disease in a patient with chronic diarrhea, and weight loss
Level 5 <i>Recognizes rare presentations of common diagnoses and/or presentations of rare diagnoses</i>	<ul style="list-style-type: none"> ● Recognizes that spiculation of mass on imaging raising neuroendocrine tumor as the etiology
<i>Aware of cognitive biases and demonstrates behaviors to overcome them</i>	<ul style="list-style-type: none"> ● Recognizes potential towards anchoring bias, leads multidisciplinary conference to obtain input ● Personally elicits input from other subspecialists in complex diagnostic cases

Overall Intent: To engage in the analysis and management of patient safety events, including relevant communication with patients, families, and health care professionals; to conduct a QI project	
Milestones	Examples
<p>Level 1 <i>Demonstrates knowledge of common patient safety events</i></p> <p><i>Demonstrates knowledge of how to report patient safety events</i></p> <p><i>Demonstrates knowledge of basic quality improvement methodologies and metrics</i></p>	<ul style="list-style-type: none"> ● Lists patient misidentification or medication errors as common patient safety events ● Describes how to report errors in their institution ● Describes Plan, Do, Study, Act (PDSA) cycle
<p>Level 2 <i>Identifies system factors that lead to patient safety events</i></p> <p><i>Reports patient safety events through institutional reporting systems</i></p> <p><i>Describes local quality improvement initiatives</i></p>	<ul style="list-style-type: none"> ● Identifies lack of hand sanitizer dispenser at each clinical exam room may lead to increased infection rates ● Reports lack of hand sanitizer dispenser at each clinical exam room to the medical director ● Summarizes protocols resulting in decreased spread of hospital acquired <i>C. diff</i>
<p>Level 3 <i>Participates in analysis of patient safety events (simulated or actual)</i></p> <p><i>Participates in disclosure of patient safety events to patients and families (simulated or actual)</i></p> <p><i>Participates in local quality improvement initiatives and describes quality improvement regulatory requirements relevant to transplantation (e.g., Center for Medicare and Medicaid Services, Organ Procurement and Transplantation Network, organ procurement organizations)</i></p>	<ul style="list-style-type: none"> ● Prepares for morbidity and mortality presentations ● Communicates with patients/families about a procedural complication ● Participates in project identifying root cause of readmission for patients with cirrhosis
<p>Level 4 <i>Conducts analysis of patient safety events and offers error prevention strategies (simulated or actual)</i></p>	<ul style="list-style-type: none"> ● Collaborates with a team to conduct the analysis of a procedural complication and can effectively communicate with patients/families about those events

<p><i>Discloses patient safety events to patients and families (simulated or actual)</i></p> <p><i>Demonstrates the skills required to identify, develop, implement, and analyze a quality improvement project</i></p>	<ul style="list-style-type: none"> ● Participates in the completion of a QI project to improve viral hepatitis vaccination rates in patients with cirrhosis, including assessing the problem, articulating a broad goal, developing a SMART (Specific, Measurable, Attainable, Realistic, Time-bound) objective plan, and monitoring progress and challenges
