#### Theories/Concepts/Rationale

1. Alon P, Margalit A, Glick SM, Benbassat J, Cohen A. Effect of a biopsychosocial approach on patient satisfaction and patterns of care. *J Gen Intern Med* 2004;19:485-91.

*The results of this study suggest that an intervention to teach residents a biopsychosocial approach to patient care enhanced patient satisfaction and reduced medications prescribed.*

2. Favrat B, Pecoud A, Jaussi A. teaching cardiac auscultation to trainees in internal medicine and family practice: Does it work? *BMC Med Educ* 2004;4:5 ([www.biomedcentral.com/1472-6920/4/5](http://www.biomedcentral.com/1472-6920/4/5)).

*Consistent with previous research, this study indicates that residents need more training in cardiac auscultation and that a course focusing on bedside teaching can improve these skills.*

3. Landon BE, Normand S, Blumenthal D, Daley J. Physician clinical performance assessment: prospects and barriers. *JAMA* 2003;290:1183-9.

*The writers present a rationale for assessing physicians' clinical competence and describe characteristics of ideal performance measures.*

4. Lee CL, Anderson JK, Monga M. Residency training in percutaneous renal access: does it affect urological practice? *J Urol* 2004;17:592-5.

*In this paper, a postgraduate survey revealed that urologists trained in percutaneous access were significantly more likely to perform this procedure in practice and to do so more often than physicians who did not receive this training during residency.*

5. McGlynn EA, Asch SM, Adams J, Keesey J, Hicks J, DeCristofaro A, et al. The quality of health care delivered to adults in the United States. *NEJM* 2003;348:2635-45.

*This national study indicates that adults generally receive 55% of recommended chronic, acute, and preventive care across a broad scope of clinical conditions.*

6. Whitted RW, Pietro PA, Martin G, Latchaw G, Medina C. A retrospective study evaluating the impact of formal laparoscopic training on patient outcomes in a residency program. *J Am Assoc Gynecol Laparosc* 2003;10:484-8.

*Findings in this article indicate that residents who completed structured laparoscopic training had better patient outcomes, such as reduced blood loss and hospital stay, than residents who did not receive formal training.*

7. Andrales GL, Chu UB, Hoskins DB, Witzke AE, Park AE. Development of a valid, cost-effective laparoscopic training program. *Amer J Surg* 2004;187:157-63.

*Learning tasks and assembly steps required to teach five laparoscopic procedures on inanimate models are presented in this paper.*

8. Bannister SL, Hilliard RI, Regehr G, Lingard L. Technical skills in paediatrics: a qualitative study of acquisition, attitudes and assumptions in the neonatal intensive care unit. *Med Educ* 2003;37:1082-90.

*This study describes variables that influence the teaching and learning of residents' procedural skills in a busy hospital unit.*

9. Clever SL, Novack DH, Cohen DG, Levinson W. Evaluating surgeons' informed decision making skills: pilot test using a videoconferenced standardized patient. *Med Educ* 2003;37:1094-9.

*In this study, surgeons indicated that their interactions with and feedback from a remote standardized patient via videoconference was a helpful approach to learning about informed decision making skills.*

10. Corton MM, Wai CY, Vakili B, Boreham MK, Schaffer JI, Coleman RL. A comprehensive pelvic dissection course improves obstetrics and gynecology resident proficiency in surgical anatomy. *Am J Obstet Gynecol* 2003;189:647-51.

*The writers describe a three-week laboratory-based course that improved residents' knowledge and skills in surgical anatomy.*

11. Houston TK, Connors RL, Cutler N, Nidiry MA. A primary care musculoskeletal clinic for residents. *J Gen Intern Med* 2004;19:524-9.

*The steps used to design and implement a primary care musculoskeletal curriculum are described in this paper.*

12. Reilly JM, Ring J. An end-of-life curriculum: Empowering the resident, patient, and family. *J Palliat Med* 2004;7:55-62.

*A comprehensive resident curriculum to teach all aspects of end-of-life care from discussing advance directives to pronouncing death is described in this paper.*

13. Siebens H, Cairns K, Schalick WO, Fondulis D, Corcoran P, Bartels E. PoWER Program: people with disabilities educating residents. *Am J Phys Med Rehabil* 2004;83:203-9.

*This paper describes an initiative that teaches residents about adaptations and lifestyles of people with disabilities through home and work-site visits.*

14. Yeheskel A, Biderman A, Borkan JM, Herman J. A course for teaching patient-centered medicine to family medicine residents. *Acad Med* 2000;75:494-7.

*A three-year course designed to teach patient-centered medicine through Balint groups, role-plays, case presentations, open discussion, and directed reading is described in this paper.*

15. Brazeau-Lamontagne L, Charlin B, Gagnon R, Samson L, Van der Vleuten C. Measurement of perception and interpretation skills during radiology training: utility of the script concordance approach. *Med Teacher* 2004;26:326-32.

*This article describes a valid and reliable approach to assess radiology perception and interpretation abilities.*

16. Fraser SA, Klassen DR, Feldman LS, Ghitulescu GA, Stanbridge D, Fried GM. Evaluating laparoscopic skills: setting the pass/fail score for the MISTELS system. *Surg Endosc* 2003;17:964-7.

*By comparing the performance of experienced and less experienced physicians, the writers were able to calculate a cutoff score with the highest sensitivity and specificity.*

17. Holmboe ES, Huot S, Chung J, Norcini J, Hawkins R. Construct validity of the MiniClinical Evaluation Exercise (MiniCEX). *Acad Med* 2003;78:826-30.

*Using the MiniCEX to rate the clinical skills of standardized residents, faculty were able to distinguish between unsatisfactory, marginal, and superior performances thus providing evidence of construct validity.*

18. Kneebone RL, Nestel D, Moorthy K, Taylor P, Bann S, Munz Y, et al. Learning the skills of flexible sigmoidoscopy – the wider perspective. *Med Educ* 2003;37:50-8.

*In this study, procedural and communication skills are taught and assessed through scenarios that require interaction with a standardized patient and a virtual reality simulator.*

19. Ringsted C, Ostergaard D, Ravn L, Pederson JA, Berlac PA, Van der Vleuten C. A feasibility study comparing checklists and global rating forms to assess resident performance in clinical skills. *Med Teacher* 2003;25:654-8.

*With regard to assessing complex anaesthesiology skills, clinicians preferred checklists with task-specific items to global rating forms.*

20. Sloan DA, Plymale MA, Donnelly MB, Schwartz RW, Edwards MJ, Bland KI. Enhancing the clinical skills of surgical residents through structured cancer education. *Ann Surg* 2004;239:561-6.

*The writers describe an 11-problem OSCE used to assess the impact of resident participation in a breast cancer instruction module.*

21. Smith CC, Gordon CE, Keller-Kopman D, Huang GC, Weingart SN, Davis RB, et al. Creation of an innovative inpatient medical procedure service and a method to evaluate house staff competency. *J Gen Intern Med* 2004;19:510-3.

*This article describes the Medical Procedure Service designed to provide a standardized approach to teaching and assessing inpatient medical procedures.*

22. Tsai TC, Harasym PH, Nijssen-Jordan C, Jennett P, Powell G. The quality of a simulation examination using a high-fidelity child manikin. *Med Educ* 2003;37:72-8.

*Checklists used to rate performance with a high-fidelity child manikin yielded reliable and valid information about residents' technical skills, medications used, and other behaviors relevant to managing emergency pediatric cases.*
