

Denni RC f The function of the Review Committee is to set accreditation standards (i.e., requirements) and to provide peer evaluation of residency and fellowship programs. The purpose of the evaluation is to assess whether a program is in substantial compliance with the applicable Program Requirements, and to confer an accreditation or recognition status.

- Four nominating organizations ABR [American Board of Radiology], ACR [American College of Radiology], AMA [American Medical Association], AOA [American Osteopathic Association]
- 12 voting members


(includes one resident and one public member)



### ESIR Annual Data Collection Summary

**Program-Level Data** 

- 164 programs (83.2%) have ESIR

' - 164 programs (83.2%) have an active interventional radiology clinical service in the radiology department.

- 163 programs (82.7%) have at least 50 percent of all interventional radiology-related rotations spent performing interventional radiology procedures (one narrative response) #ACGME202!



#### **ESIR Annual Data Collection Summary**

#### **Faculty-Level Data**

- 962 faculty members listed for the 164 ESIR programs

- Range was one to ten faculty members, with a median of six faculty members per program

' - 37 programs (22.6%) listed at least nine faculty members

' - 905 faculty members (94.1%) were listed as American Board of Medical Specialties (ABMS) certified

' - Approximately 390 (43.1%) of the Certificate Names mentioned Interventional Radiology.

' - Almost all of the specialty areas (884, 97.7%) mentioned interventional radiology

-36 programs also mentioned other qualifications for at least one of their faculty members

### Review Committee Discussions





#### **Board Certification**

#### **ACGME Requirement:**

V.C.3.a) For specialties in which the ABMS member board and/or AOA certifying board offer(s) an annual written exam, in the preceding three years, the program's aggregate pass rate of those taking the examination for the first time must be higher than the bottom fifth percentile of programs in that specialty. (Outcome)

For diagnostic radiology, the annual pass rate on the Core Exam is evaluated for this requirement.

#### **ACGME Requirement:**

V.C.3. One goal of ACGME-accredited education is to educate physicians who seek and achieve board certification. One measure of the effectiveness of the educational program is the ultimate pass rate.

The program director should encourage all eligible program graduates to take the certifying examination offered by the applicable American Board of Medical Specialties (ABMS) member board or American Osteopathic Association (AOA) certifying board.

No current utilization of this data, but being collected by the ACGME.




- 1. Discussion of board certification and board pass rate
  - a. Core Exam. Fifth percentile.
  - b. Certification exam data. No current utilization of this data, but being collected by the ACGME.
    - i. Steven Stain on the ACGME's Common Program Requirements Task Force suggests that first-time certification pass rate measures the program quality.
  - c. Mention ABR diagnostic radiology oral exams or possible second interventional radiology oral exam will not change collected certification data.



#### Remote Supervision GUIDELINES

- Remote supervision hot topic in radiology
- Many practices currently rely on teleradiology to serve their institution's needs for radiology coverage
- ACGME-accredited radiology residency and fellowship programs may have faculty members who work remotely

### **Remote Supervision in Radiology**

- "Four solutions to the biggest challenges facing remote radiologists" Radiology Business, January 6, 2025
- Over 200 members of Association of Academic Radiology (AAR) surveyed
- Optimized education and trainee supervision: Remote work and the expansion of academic and private practices across multiple sites pose challenges to trainee education and supervision. Faculty development programs focused on pedagogically sound remote teaching and supervision methods are crucial. This would enhance remote faculty engagement in educational missions and support equal involvement in mentorship opportunities for trainees."

- Eliminate roles: Assisting, Primary, and Secondary roles? Retain "Primary" only
- Interventional radiology minimums to be discussed in 2026-2027 after complete class progression
- Review Committee evaluating interventional radiology independent Case Logs to reflect at least 500 procedures for each graduate; will start citing this area next year
- Commonly noted that interventional radiology Case Logs show "0" for Outpatient Clinic – programs can expect an Area for Improvement (AFI)

#### Site Visits Continued Accreditation Status

- As of 2024, the ACGME began conducting site visits annually for approximately one to two percent of programs with a status of Continued Accreditation that have not had a site visit in 10 or more years
- These site visits are determined through a sampling process and support the ACGME's responsibility to the public
- All selected programs for 2025 were notified in January of the site visit target date (May – July 2025)
- As a reminder, the 10-year accreditation site visit has been discontinued
- The program Self-Study requirement has been paused, but will be reconfigured and will no longer be linked to a site visit


